# Fields of law apt for legaltech?

- Simple cases
- Clear cases (usually, interpretation is not necessary)
- Ideally, facts may automatically be found/veryfied in the internet (eg: flight delays)
- High number of repetitive, identical cases

# Fields of law apt for legaltech?

- Flight rights,
- Rental disputes
- Social law (in German; eg certain benefits)
- Labour disputes
