

TALLINNA VESI SCHOOL OF BUSINESS AND GOVERNANCE BACHELOR'S STUDY SCHOLARSHIP

AS Tallinna Vesi is the largest water company in Estonia, providing water and sewerage services to almost a third of the Estonian population. In Tallinna Vesi, we create a better life with clean water every day by applying engineering knowledge and we contribute to the balance of the natural environment.

1. **Tallinna Vesi School of Business and Governance Bachelor's Study Scholarship** is intended for one successful TalTech bachelor's studies student studying at the School of Business and Governance, who meets the following requirements:
 - Matriculated at TalTech and not on academic leave as at the moment of submitting the application;
 - Doesn't have a valid employment relationship (including contractual agreement) with AS Tallinn Vesi and/or Watercom OÜ (except internship);
 - Study performance volume at least 60 ECP by the day of submission of the application;
 - An active attitude to life and a fan of his/her area of specialisation, aiming to become a top specialist in the area;
 - An opportunity to sign a contract with AS Tallinna Vesi, outlining an agreement for an internship and/or thesis work;
 - An opportunity to participate in at least one project with AS Tallinna Vesi, during which a professional task will be solved.
2. The source of the scholarship is the amount transferred to the TalTech Development Fund by the scholarship sponsor.
3. The amount of the bachelor's study scholarship is **2000 EUROS**. The scholarship shall be paid in one lump sum payment.
4. The scholarship shall be applied for and awarded by way of public competition. The competition shall be announced via various information channels of TalTech and at least one national newspaper.
5. In order to apply for the scholarship, applicants shall have to submit the following to the Management Board of the Development Fund:
 - A motivation letter or a 1–2 minute video on the topic:
 1. Option: "How can we help ensure clean drinking water for future generations?"

2. Option: "How can we make cities more water-smart and environmentally friendly?"
- *Curriculum Vitae*;
 - An extract from study results (from the Dean's Office);
 - A recommendation from a lecturer, a practical training supervisor, a previous employer or the head of a (student) organisation (in which you have been an active contributor).
6. The Management Board of the Development Fund shall register the applications submitted for the scholarship and organise the forwarding of the documents to the sponsor. Upon its wish, the sponsor may meet with the scholarship applicants before selecting the receiver of the scholarship.
7. The final decision on the selection of scholarship holders and whether or not to appoint a scholarship is made by the scholarship sponsor.
8. The receiver of the scholarship shall be approved by the Management Board of the Development Fund on the basis of the sponsor's proposal. The scholarship shall be paid to the bank account notified to the Management Board of the Development Fund by the receiver of the scholarship.
9. The Management Board and the Supervisory Board of the Development Fund shall settle any possible problems related to awarding the scholarship.
